
Introduction

The following is an analysis of the results of an evaluation of application of the DDS 500 Ambulatory Pneumatic Traction Lumbar Sacral Orthotic Medical Device as reported by 879 users. A questionnaire was sent out in late 2011 and again in early 2014 by Disc Disease Solutions (DDS) with the sole objective of gathering personal use feedback from actual DDS 500 users in the market. These questionnaires were not intended to nor do they fall under guidelines, protocols, standards or policies of any governing agencies whose purpose is overseeing questionnaires of this nature either in or out of the medical industry, conducted for formal reporting. This analysis will not be reported to any agencies with the intent to be formally published within any medical journals for review.


Subjects and Methodology

DDS mailed out a multi-page questionnaire to all DDS 500 users who received the DDS 500 Brace within the time period of 01/01/2009 and 12/20/2013 and who had registered their product. The total amount of questionnaires that were mailed out exceeded just over 2100 and total amount of fully completed questionnaires that were returned was 879. Questionnaires that were returned which were not fully complete or in which it was obvious that the participant did not fully understand the question(s) were discarded and not counted in the final results. With the exception of a few questions of the questionnaire that were asked for internal office use, the results of the 879 users of the DDS 500 who responded are found on the following pages.


PATIENTS AGE

Were you Able to Resume More Normal Daily Activities as a result of Wearing the DDS 500?








How Long After First Applying the DDS 500 Were You Able To Resume Normal Activities?





If Yes, Which Activities?




Before Receiving the DDS 500, were you Already Wearing Another Back Brace?



How Long do you Wear the DDS 500 Each Time?







How Comfortable is the DDS 500?





How Durable is the DDS 500?




Does Wearing the DDS 500 Help You Sleep?

Highlights

It is shown that the DDS 500 LSO is effective at providing relief to patients suffering from back pain (65 percent felt relief within the first hour) resulting in them being able to avoid surgery (44% of the 396 patients who were prescribed the brace in an effort to avoid surgery), allowing 65 percent to resume more normal daily activities (37 percent within a week of first wearing the brace). 68 percent of those who were already wearing a different kind/brand of LSO reported that the DDS 500 is far superior to their previous brace. Additionally, 33 percent report wearing the brace once a day and another 33 percent report wearing it twice a day, and 35 percent report wearing it for 2 hours at a time while 33 percent report wearing it 4 hours at a time. Concerning comfort, 71 percent report the brace rating between 6 and 10 in comfort, with 10 being the most comfortable. 68 percent report the brace to be extremely durable. 39 percent say the DDS 500 helps them sleep better at night either by a lot or moderately. An astonishing 91 percent report they would recommend the brace to their friends and family.

The ages of the participants range from 18 to 85 with 29 percent aged between 76-85, 35 percent were aged between 66-75 and 19 percent aged between 56-65.

Conclusion

The DDS 500 is a viable and effective device to help individuals who suffer from low back pain to find relief and get their lives back by being able to return to their normal daily activities.
